

Greg Francoeur Memorial Scholarship Fund Application

Greg Francoeur was an avid skier who took great joy in sharing his love of the sport. He was particularly interested in helping younger skiers perfect their technique and devoted many hours to the students enrolled in the weekend program at Carrabassett Valley Academy. Greg received a B.S. (Zoology) from the University of Maine, Orono, and a master's degree (Immunology) from the University of Southern Maine. Greg had completed all but his dissertation for a Ph.D. (Immunology) from the University of Maine, Orono at the time of his death. He was awarded his Ph.D. posthumously in September 2005. Greg authored several peer-reviewed articles that were published in scientific journals and is listed as inventor on several U.S. patents. Greg's family and friends established this fund to celebrate Greg's passion for excellence and to encourage others to strive for their personal best.

Scholarship support will be provided to students enrolled at Carrabassett Valley Academy who would not be able to take advantage of educational and training opportunities without financial assistance. While skiers of all styles are invited to apply, Greg's forte was freestyle and the Advisory Committee is particularly interested in supporting skiers who share the same interest.
